AviSyst is a fully digital Aviation Management Suite, built for small to medium sized General Aviation businesses. It was born out of a requirement to have a simple and user friendly way to enter and receive data about flight operations. It has been built from the ground up by an active pilot and manager. This means that every decision about what to include, how to present it and how to enter data is as practical and user friendly as possible.

By using a digital Daily Flight Record instead of paper, it allows all the information that is always written down but never logged, to be stored, accessed and analysed easily and forever.

Managers can see in real time; the current stage and task an aircraft is engaged in, live TTIS and MR item tracking, current F&D's, staff currencies, whether a flight has been assigned to an invoice and much more. With AviSyst, total transparency and accessibility is given to management from any device, anywhere, anytime.

Pilots benefit by having to click one button at the end of the day to complete all their administration. No calculations, no chance of mistakes, no manual forms to fill in online.

The latest SMS module allows incident reports, investigations and instant distribution of safety information. AviSyst aid's in bringing operators in line with the Part 91 SMS requirements, as well as demonstrating SMS awareness and compliance to current and future clients. All at a complexity level for GA companies, not airlines.

With automatic error checking, smart drop down lists and pre-filled data, the Digital DFR is what makes AviSyst such a powerful tool.




Digital passenger manifests that integrate with the aircraft Daily Flight Record and lookup current fuel level to calculate W&B Checks.

AviSyst automatically calculates the Flight and Duty status of a pilot within seconds of the DFR being closed, there is no requirement for a pilot to manually enter details.

An easy to view dashboard displays the F&D status of all pilots. This allows for logistic and rostering decisions to be made quickly. Alerts are sent to the pilot and any relevant managers if a pilot is now restricted to certain operations or appendices.



AviSyst follows the latest CASA CAO 48.1 limitations. Custom FRMS limitations can be added, contact us for information.



Currencies and qualifications can be uploaded easily from any device into AviSyst. Expiry alerts are sent to individuals and managers to reduce the chance of missing an expiry or re-certification date.

Currency tracking is not just for pilots, other staff such as crewman, fuel truck drivers etc... are able to be added into you AviSyst and have their details uploaded.
